

Amblitel's Cloud 9 Living / Outsource Assessment Drawing - Official Rules

No purchase necessary. Void where prohibited. Some restrictions apply. One qualifier per ambulatory surgery center. You need not be present to win.

THE DRAWING: From 4/5/2010 through 6/4/2010, Amblitel will promote, by means of our website, letters in the mail, email, and at the ASC 2010 Convention in Anaheim, CA, the opportunity to submit entries to win one of three prizes as detailed below.

ELIGIBILITY: In order to submit entries, you must be employed by an ambulatory surgery center.
